## NOMINATION RULES

### Nomination for PRESIDENT

- Nominees for the position of President must have served at least a two year term on the Clubs New Zealand Board at the date of election (clause 13.2).
- Be signed on behalf of any two (2) financial member clubs (clause 13.1).
- Must state the name and address of the nominee (clause 13.1(b)).
- Must be signed by the nominee as consenting to the nomination (clause 13.1(e)).
- Nominations for the position of President must reach the Chief Executive no later than 4.00pm, Wednesday 20th January 2023 (Clause 13.3).

### Nominations for AREA BOARD MEMBERS

- Nominating clubs shall be confined to clubs located in each of the areas (clause 12.1(c)).
- Be signed on behalf of any two (2) financial member clubs (clause 13.1).
- Must state the name and address of the nominee (clause 13.1(b)).
- Must be signed by the nominee as consenting to the nomination (clause 13.1(e)).
- Nominations for Area Board Members must reach the Chief Executive no later than 4.00pm, Wednesday 20th January 2023 (Clause 13.4).
