#### **Tournament Rules**

- Competitors must register by 8pm Wednesday 10th November 2021
- Current license must be produced at registration.
- Fishing by contestant is restricted to Rotorua District waters except for Lake Aniwhenua,
   Flaxy Lake and Wild River Fisheries and shall be in accordance with the Eastern Region Fish & Game Council rules and regulations.
- Daily prizes restricted to fish caught on Lakes Rotorua, Okataina, Tarawera and Rotoiti.
- No cleaned or frozen fish will be accepted
- The Judicial Committee representing the organising committee will convene to deal with any dispute. This committee's decision will be final.
- The competition will begin at 5am Thursday 11th November 2021 and run to 2pm Saturday 13th November 2021.

The weighing station will operate at the Rotorua Citizens Club:

Thursday 11th November 3pm-5pm
Friday 12th November 3pm-5pm
Saturday 13th November 2pm-4pm
Side Entry through the back gate (garden bar)

Must be in queue before 5pm on 11th & 12th & 4pm on the 13th No Exceptions
