He also confirmed that the dates would be the same as for this tournament, however, on checking the Calendar for November 2021 the tournament will commence from Monday the 8th November to Thursday 11th November 2021.

Remit: on behalf of Levin Cossie Outdoor Bowls Adjunct from their Secretary Viv Hudson reads as follows:-

“The Levin Cossie Outdoor Bowls Adjunct would like to propose that the Clubs New Zealand North Island Women’s Outdoor Bowls Tournament, be held one year in the North of the North Island, and one year in the Southern part of the North Island. By this we mean North of Taupo and South of Taupo”

- 2021 Hamilton Workingmen’s Club (North of Taupo)
- 2022 Levin Cosmopolitan Club (South of Taupo)
- **2023 Host required North of Taupo**
- 2024 St John’s Club (South of Taupo)

General Business – One of the Delegates brought up whether the tournament could change dates due to weather conditions at this time of year and also an example for change was that last year the Tokoroa Club had to change due to the Kinleith Shut .

Terry replied that the Host Clubs could negotiate any changes required with Clubs NZ if necessary.

There being no further General Business, Terry thanked all those for attending the meeting and wished them well for the rest of the Tournament.
