Eileen Stephens, Raglan Club spoke on the **Conditions of Play** for Manurewa's Tournament. The following were her suggestions to change.

Clause 8 (iv) (Leave subclauses i, ii, iii and v as they are)

Subclause iv to read:

No change of players will be allowed except in cases of illness or some other reasonable cause as approved by the controlling body. Bowls New Zealand Domestic Regulation Clause 2 shall apply... Once an entry has been accepted, as per Clause 1 of the COP for this tournament, a 'Change of player prior to the start of the event' can be lodged and approved by the controlling body. This player is NOT considered to be a substitute and can play in any position in the team. See BNZ Domestic Regulations Clause 2.2. Once the tournament has started a substitute can be applied for and approved by the controlling body, this player may NOT play as skip as per BNZ Domestic Regulations Clause 2.4.

Explanation: A team is entered into the competition. If it is a composite team, the player from the minority club CANOT play as skip (as per Clause 1 of the COP for this event – this is correct and does not need changing at all). If a 'change of player before the event starts' is requested, the controlling body has to approve this request but this player can play in any position as they are NOT considered to be a substitute. Then, once the game has started a substitute has to be approved by the controlling body and this player CANNOT play as skip.
